- The Units of ICL Balanced Fund/BCB ICL Growth Fund/Esquire ICL Apparel Fund/ICL INCTL Shariah Fund hereinafter referred to as the Fund, may be bought through Impress Capital Limited (ICL) and authorized selling agents appointed by ICL from time to time. Repurchase/Surrender of Units is allowed only through ICL or the selling agents appointed by ICL from time to time.
- Units may be repurchased/surrendered on all working days except last working day of the week and during the book closure period/record date of the Fund.
- Minimum repurchase/surrender quantity is 100 (one hundred) Units for individual and 10,000 (ten thousand) units for institutional unit holders.*
- Partial surrender is allowed without any additional cost subject to minimum surrender quantity of 100 (one hundred) Units for individuals and 10,000 (ten thousand) units for institutions.

 Upon partial surrender, the unit holder will be issued with a new Confirmation representing the balance of his/her Unit holding.*
- Unit holder is required to attach the Confirmation of Unit Allocation Letter(s) he/she/the institution wants to repurchase along with this repurchase form.
- After verification of authenticity of Confirmation of Unit Allocation Letter(s), account payee cheque for surrender amount will be issued in favor of unit holder within maximum of five working days. In case of joint holding, account payee cheque will be issued in favor of principal holder.
